My main duties at the present time include, managing the team of Operations Delivery Managers, Delivery Assistants and Operations Delivery Supervisors who are responsible for the delivery of possessions and associated Network Operations activities, management of in house teams and contracted in possession management staff.

Our team provides provision of expert possession management input into the planning process, and I carry out local (level 1 & 2) and formal (level 3) investigations as directed by the (DCP) following up any identified actions.

I am also responsible for the budget of the SODM team and the delivery of special projects delivered by in house staff.

I also brief staff as directed and carry out management visits and safety checks on in house and contracted staff also insuring contract staff receive all relevant cascade briefs.

Provision of expert possession management input into the planning process, carrying out local and formal investigations as directed by the Senior Operations Delivery Manager (DCP) following up any identified actions.

I also assist in the production of PICOP safety (Possession & SSoWPs) packs and briefing materials, I also chair the Ballast and OTM performance meeting, and we also hold site meetings and produce minutes.

I also brief staff as directed and carry out management visits and safety checks on in house and contracted staff.

Promoted to the position of Possession Delivery Manager with direct responsibility for 23 staff and the safe and efficient delivery of possessions within the Scotland East area.

My main duties are to lead and direct the detailed planning, Resourcing and delivery of allocated possessions and the worksites within them. Carry out detailed planning of all possessions. Delivery the access management and supporting activities for all possessions designated by the Possession Delivery Manager. This also included PICOPing various possession in the East area of Scotland.

My key accountabilities were -

- 1. Ensure the efficient and safe planning and organisation of all possession management activities on designated possessions.
- 2. Ensure the appropriate planning; safety and performance measures are being applied to all engineering possessions.
- Ensure that all possession protection and management arrangements comply with and relevant Group and Company Standards (including the Network Rail Rule Book)
- 4. Delivery of improved efficiency, reliability and operational safety of possessions.
- 5. Identify risks and mitigation measures to be applied to possession arrangements on a site-by-site basis.
- 6. Ensure the robustness of the possession arrangements including the interfacing of worksites and the associated train plans.
- 7. Lead possession coordination meetings to manage conflicts and accommodate changes at the earliest opportunity.
- 8. Management and briefing of possession protection staff (PICOP brief)
- Ensure that all emergency arrangements in connection with any possession are in place together with arrangements to deal with any environmental incidents.
- 10. Monitor and report on possession safety and efficiency by production of post-possession report. Identify lessons learnt including training, competency issues and recommendations and submit to the Possessions Delivery Manager.
- 11. Audit sites to ensure contractors are adhered to procedures and are in possession of relevant certification.
- 12. Co-ordinate and compile associated Risk Registers and Method Statements in respect to the possession.
- 13 Produce Possession Packs including compilation of Health and Safety plan, Staff Rosters for possession, Plant & Equipment, Sub-contractors, Train Requirements and movements, Possession details and specific work site information.

Main Duties

In the post of Workforce Safety Coach I developed and implemented a plan of on-site safety surveillance checks on maintenance works managed by the are team to verify compliance with health, safety, and environment legislation, standards and method statements. I have also carried checks on machine controllers and operators in compliance with the train operations manual rules and regs.

These planned checks are supplemented by ad-hoc checks on specific sites to cover T2 protection, Red/Green zone working and other issues. I maintain an adequate record of all checks and I ensure the results of checks are input into relevant databases and communicated to the relevant managers.

I also ensure as part of my role that progress reports are followed up regarding the implementation of corrective actions identified by these safety checks. I also represent the area team at contractor safety meetings to discuss the results of safety surveillance checks.

In this role I provided assistance to the area team in review and acceptance of contract health and safety documentation including health and safety plans, method statements and risk assessments. Part of my duties was to coach line managers to investigate accidents and incidents.

I also carry out safety briefings as required throughout the Scotland East area, These included writing briefings on the Train Operations Manual and briefing them out throughout the area to comply with company standards.

I was also involved at staff briefings and at various tool box talks delivering the briefings and talks as required by the Workforce Safety Advisor, these included various track safety subjects and occupational Health and Safety items.

I have gained qualifications in construction whilst attending Technical college throughout my apprenticeship. I have a basic knowledge of the CDM regulations gained whilst studying for my NEBOSH certificate.

I have also gained experience carrying out investigations into incidents / accidents and compiling local reports. I also compile local area work instructions and procedures as required.

During the normal course of my duties I have gained vast experience dealing with staff on a number of issues regarding workforce safety issues and

numerous other issues affecting staff working on the track, I have learnt through these occasions the different temperament you require when dealing with staff at all levels within the business.

Network Rail Site Safety Inspector (East) (May 2003 – Nov2004)

Main Duties

The main purpose of this role was to ensure the infrastructure maintainers were compliant with rules and regulations as regards to there possession management under the IMC2 contract between Network Rail and the contractor.

This was achieved by completing a programme of ad-hoc site visits and by arranged visit to also ensure that the actual safety of the site was adequate and compliant with company procedures, standards, and method statements.

Any deficiencies found were actioned at contractor safety meetings and by written report to ensure close out; all actions were also tracked by me.

Network Rail Signaller – Carmuirs West Junction & Plean Junction

Main Duties

To ensure the safe running and regulating of trains in accordance with rules and regulations which included dealing with any incidents or occurrences that arose on a day to day basis.
